- Making the most faithful use of all resources (volunteers, staff, finances, and property) that God provides



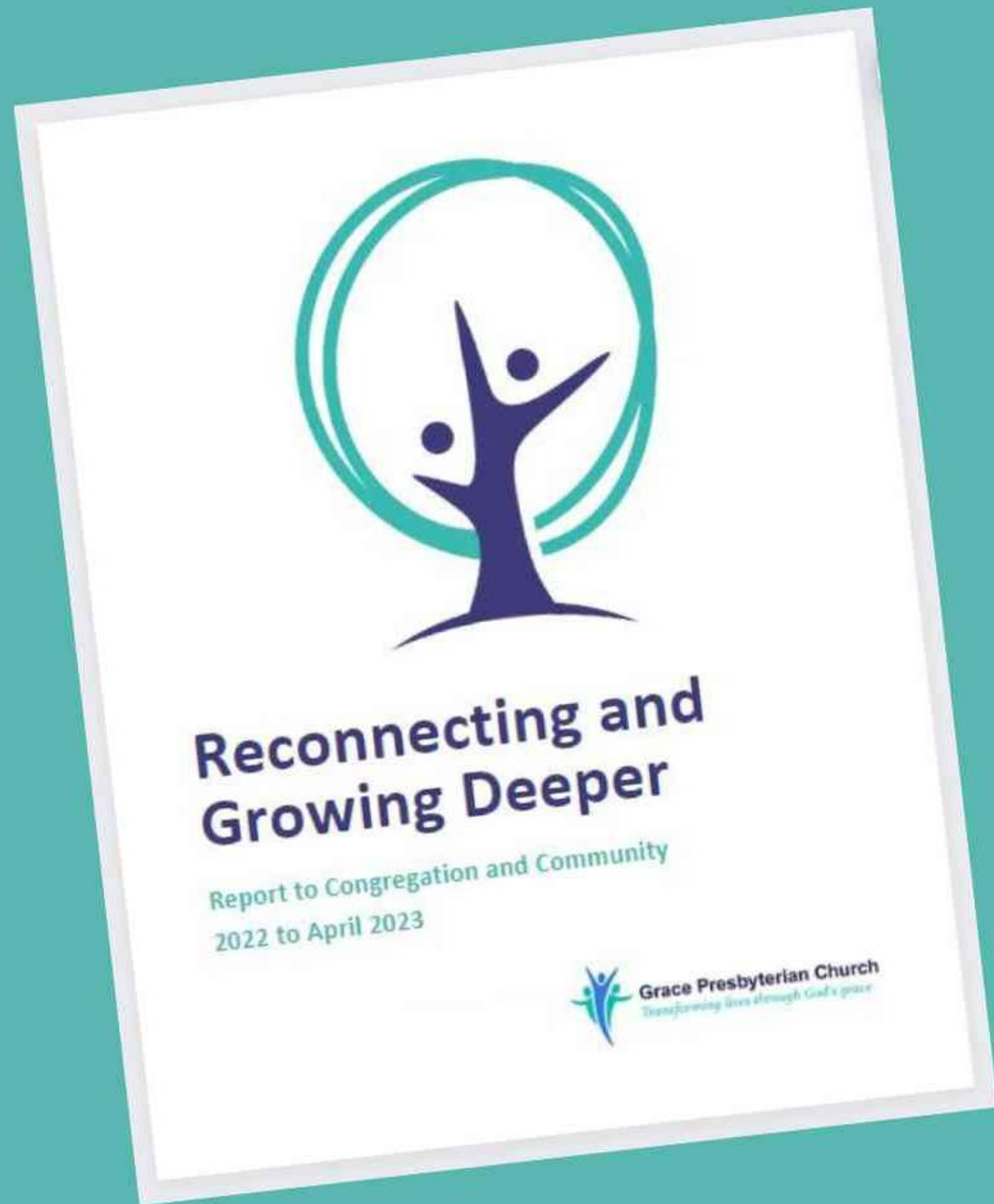
Stewardship continued

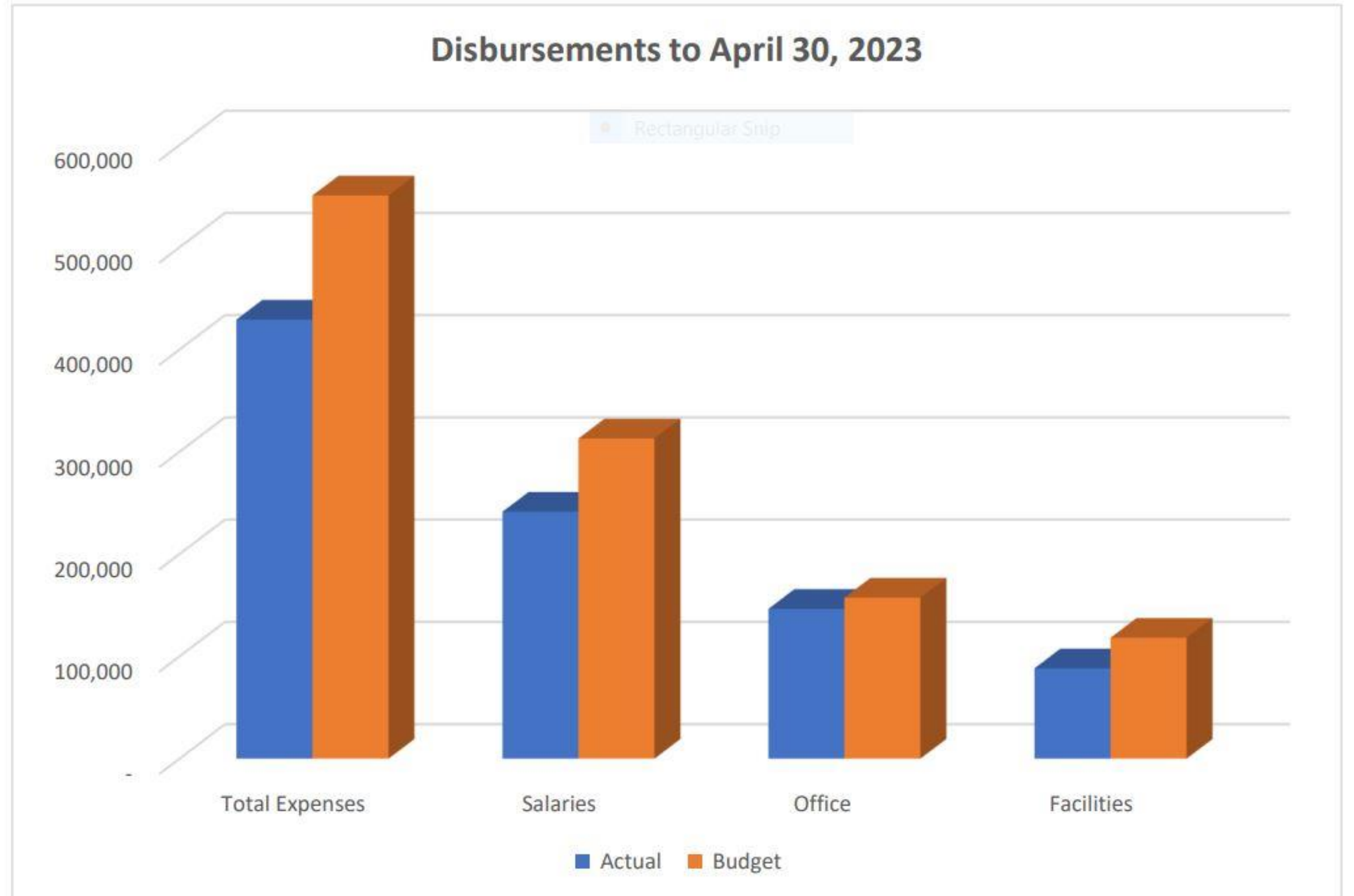
